_____ I authorize the credit card listed above to be used as a damage/security deposit for each snowmobile I rent. I am fully responsible for this snowmobile and will pay for all broken, cracked, bent, ripped and missing pieces of my snowmobile if damaged while in my possession. I will inspect my snowmobile prior to riding it and note any previous damages on the "Snowmobile Checkout Form" during the pre-ride inspection. I'm agreeing to pay for all damages today.

_____ If my snowmobile is wrecked/damaged while in my possession and determined by On The Trail Rentals Staff to be Totaled and not worth repairing, I agree to pay full retail price plus tax for the snowmobile.

_____ I understand that there is ½ hour minimum labor charged to all damages. Labor rate is \$120 per hour. Labor Rate is calculated using the Manufacturers Flat Rate Manual and multiplying by 1.3 I agree to pay the manufacture suggested retail price for parts.

_____ If I need to be rescued, towed or I am STUCK, for non-mechanical reason, there will be a minimum \$100 rescue fee. This fee includes 1 hour of rescue. Each additional hour will be billed at \$100 per hour.

_____ I understand that there will be a minimum 3 days "Loss of Rent" (not to exceed 14 days) charge for all major damages to snowmobiles caused by rollovers and collisions. Loss of Rent Rates are visibly posted.

_____ Included with each rental are suits, boots, and a helmet. If I damage, lose or blood contaminate any of these items, I authorize a \$100 fee for boots, \$75 fee for helmets, and \$250 fee for suits to be charged to my credit card listed above.

_____ I Agree to Ride Sober. We turn all alcohol and drug related issues over to the Grand County Sherriff.

_____ I understand that On The Trail Rentals does NOT refund money for early returns on rentals and guided tours.

_____ I understand that there are additional charges if we do not return the snowmobiles back on time. Rental return times will be noted on the "Snowmobile Checkout Form". It is my responsibility to know what time I am due to return.
